THE PUBLIC SECTOR PROFESSIONAL ACCOUNTANT (ZIMBABWE) (PSPA(Z)) IS AN ICAZ ACCOUNTANCY QUALIFICATION OFFERED THROUGH ELLCHART BUSINESS SCHOOL



The Public Sector Professional Accountant (Zimbabwe) (PSPA(Z)) is an accountancy qualification offered by the Institute of Chartered Accountants of Zimbabwe. The PSPA(Z) Conventional Learning Program (CLP) is a three-year program designed for those in the public sector and those wishing to pursue an accounting and finance career in the public sector.

This program is offered through a collaboration of the Institute of Chartered Accountants of Zimbabwe (ICAZ), Public Service Academy (PSA) and Ellchart Business School. Ellchart is the educational service provider in the collaboration.

Successful students will earn the prestigious ICAZ Public Sector Professional Accountant (Zimbabwe) membership designation and will become Registered Public Accountants with the Public Accountants and Auditor Board (PAAB).

Ellchart also works with Public Service Academy (PSA) in providing the PSPA(Z). PSA is the training division of the Public Service Commission.



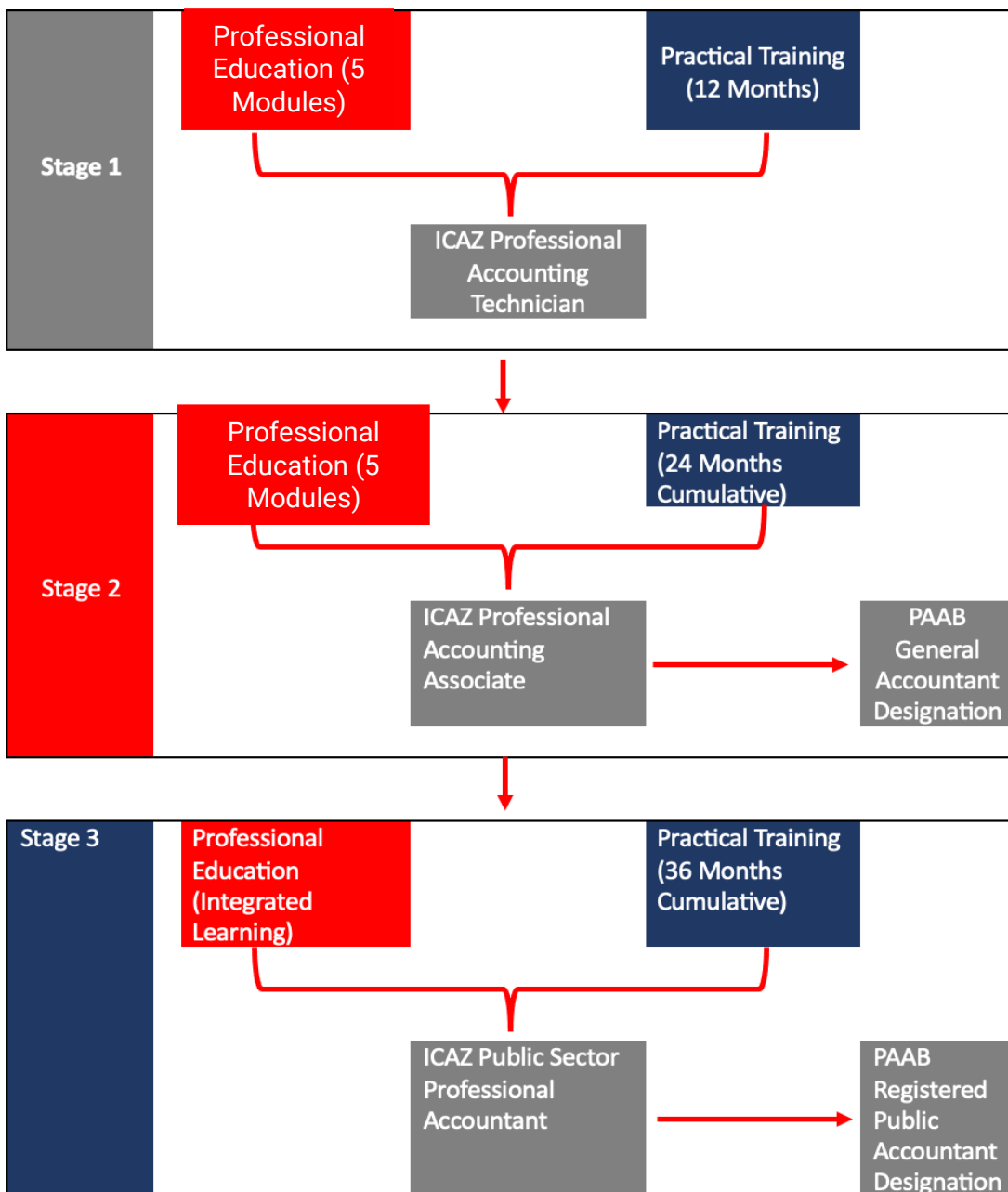
Benefits of the PSPA(Z)


